Apologies were received from Max Bavin (Chief TD), Gerard Faulkner (Vice-President) and Andrew Petrie (EBU Vice-Chairman).

2 MINUTES OF THE MEETING ON 18TH NOVEMBER 2009

2.1 Accuracy

Item 5.2

Tom Townsend confirmed that he would assume responsibility for the Committee blog, but was unable to take on other aspects of publicity. Simon Cochemé agreed to liaise with Sue Maxwell on sponsorship.

Subject to these amendments, the minutes were signed as a true record.

2.2 Matters arising

2.2.1 There had been a brief reference to prize money in invitation events. It was agreed that the return of a portion of prize money won in an event which was funded or part-funded by the EBU would continue to be considered on an event by event basis.

2.2.2 It was noted that an overseas player currently eligible to represent England had competed for his country of birth in the Nordic Challenge. It was confirmed that this did not affect his eligibility in terms of WBF and EBL events, and the Conditions of Contest for the 2010 Premier League would clarify the position in regard to Home Internationals.

3 COMMITTEE PROCEDURES

3.1 Committee's Terms of Reference

Revised Terms of Reference would be agreed at the forthcoming Board Meeting, and circulated to the Committee thereafter.

3.2 Self-certification

This matter would be discussed by the Sally Bugden and David Harris, and included on the agenda for the next meeting.

4 EBU SUPPORTERS CLUB

Presenting her discussion paper "Bridge England Supporters Trust (BEST)", Sue Maxwell was joined by Sally Bugden in saying that the paper represented the formulation of conceptual ideas to harness the support for international teams from the 3000 existing tournament players and within clubs, to provide alternative funding for international representation.

5 OPEN EVENTS

5.1 Review of Open Coaching Group Reports

The reports were noted. Whilst it was conceded that there had been limited opportunities to participate in top level events since the last meeting, it was agreed that with few exceptions very little effort had been made by the pairs, and that to justify future selection there must be significantly more evidence of motivation and commitment. It was confirmed that with the exception of the pairs selected for the European Championships, funding of coaches expired on 31st December 2009.

The Chairman agreed to contact all members of the Groups to obtain feedback on the scheme, prior to a review at the next meeting.

5.2 Selection of team, reserves, Coach and NPC for the European Championships

5.3 Bonn Nations Cup

It was agreed that the Women's team for the European Championships be invited to represent England in the Bonn Nations Cup on 12th/13th May.

5.4 Tel-Aviv Bridge Festival

It was agreed that availability would be sought from the Open and Women's European Championships teams and from all remaining pairs in the Coaching Groups to represent England in the Tel-Aviv Bridge Festival on 18th – 27th February. Participation would be on a self-funding basis.

5.5 Bulgarian invitation event

Availabilities would also be sought as above for an invitation to an inaugural event in Bulgaria from 27th – 31st January.

5.6 Commonwealth Nations Cup

The Chairman reported that the winners of the Premier League had declined the invitation to represent England in the Commonwealth Nations Cup in New Delhi on 24th – 29th October. However, a team was available comprising one pair and a player from the runners-up of the Premier League, and a pair from the team that finished in third place, and this was confirmed as follows:
