<p>Your club and members' data will be recorded in our membership database, which is stored online in compliance with the GDPR. Our membership data is shared with our associated charity, English Bridge Education and Development (EBED), with whom we share offices and data systems. We will provide the club's data and your members' data to your county of affiliation where appropriate.</p> <p>A limited amount of your members' information (name, EBU number, county, post town) is listed in the database made available for use by scoring program providers and users. This is to allow the correct identification of players for scoring purposes.</p> <p>Information relating to your members' NGS grade and master point rank, together with their county of affiliation, will be generally available unless your members' have chosen for them to be private. Your members' can do this by logging on to My EBU -> Account -> My Details.</p> <p>Some of your members' data may be used by organisations that act as Data Processors on our behalf, such as Pianola and Bridgewebs. They may only use if for the specific purposes for which they act as our data processors and they are not free to pass this on to other organisations that are not connected with the EBU.</p> <p>Your members' personal data is not passed on by us for use by any other third parties whether or not connected with bridge. Full information about our data use policies, including how your members' can see what data we hold about them, how they can limit its use and how your members' can ask for inaccuracies in data to be corrected, may be found at www.ebu.co.uk/gdpr.</p>

English Bridge Union – Club Terms of Affiliation 2019-2020

1. Clubs that affiliate to the EBU must affiliate to one of its constituent counties. Clubs cannot affiliate to a County without affiliating to the EBU.
2. Clubs undertake to pay an annual affiliation fee to the EBU (and if required, also to their county). This will be invoiced early in each financial year. For the financial year 2019/20 the EBU club affiliation fee will be £26 which is inclusive of VAT. Clubs that play less than 26 sessions per annum need to pay twice the affiliation fee which £52.
3. Clubs undertake to pass on to the EBU the current Universal Membership subscription amount collected from each player for each session of duplicate bridge held in the club apart from:
 - Exempt players as defined in Section 14 of the Universal Membership Guidance Notes.
 - Exempt sessions as defined in Section 15 of the Universal Membership Guidance Notes.

The Universal Membership subscription amount is normally made up of 2 elements

- a) An amount retained by the EBU.
- b) An amount passed on to the County to which the club is affiliated. (Some counties may choose to collect this amount in a different way.)

For the financial year 2019/20

- a) The national Universal Membership subscription amount will be 39p (which is inclusive of VAT)
- b) The county subscription amount is shown in the attached document.

4. The EBU club affiliation fee and subscription amounts for the next financial year are set by the Shareholders, your county representatives, at the Annual General Meeting in November each year. Clubs will be advised of these in December. County club affiliation fees will be advised in the following February.
5. Club affiliation is for a full year (i.e. 1 April to 31 March). Club affiliation is automatically renewed annually unless the club informs the EBU by 31 December that it wishes to resign from the EBU from the following April.
6. Clubs can choose monthly or two monthly statements and pass on the subscription amounts in one of two ways:
 - a) By direct debit.
 - b) By cheque, credit/debit card or direct transfer within 10 days of the statement.
7. Clubs agree to abide by the Universal Membership Guidance Notes as published by the EBU and amended from time to time as necessary.
8. All members, in good standing, of an affiliated club will become ordinary player members of the EBU as defined in the Bye Laws.
9. Only affiliated clubs, in good standing, are eligible to access the club services provided by the EBU.
10. Only player members of the EBU, in good standing, are eligible to access the member services provided by the EBU.
11. Clubs agree to abide by the bye laws of the EBU in force at the time (see Section 2.2 of the bye laws)
12. The EBU retains the right to suspend affiliation of a club which breaches any of the terms of affiliation.
